#### **Every Option.**

Unlike post-warranty coverages offered by other diesel manufacturers, Encompass offers a choice of coverages with or without hourly limits. With Encompass unlimited plans, you're covered for the duration – regardless of how many hours your engine puts in.

# **What Encompass Covers:**

Encompass covers every engine component included under Cummins base warranty.\* After three years (two years for 19L and larger), the following components and procedures are excluded:

- Air compressors
- Fan clutches
- Fan hubs
- Injectors
- Overhead sets
- Turbochargers
- Water pumps

- Belt tensioners
- Fan idler pulley assemblies
- Injection and fuel pumps
- Non-Cummins accessories
- Vibration dampers
- Step Timing Control (STC) oil control valves

Cummins branded starters and alternators are covered for the first two years/2,000 hours or one year/unlimited hours on all engines.

<sup>\*</sup>All aftertreatment systems and direct air flow components are excluded for Tier 4. Maintenance components are excluded at the end of the third year.

#### **Every Need.**

Encompass options include up to five years of coverage for the Cummins B3.3 to 50L engines. The engines larger than 50L are available with up to three years of coverage.

Encompass gives you a choice of parts and labor, or parts, labor and travel coverage. And on certain models you can specify hourly limits. Encompass lets you buy the coverage that best suits your needs. It doesn't matter where you bought your Cummins-powered equipment – Cummins Encompass has you covered.

#### **Every Owner.**

Cummins Encompass protection plans are transferable at any time during the life of the coverage at no charge. Take your serial number to one of over 6,600 Cummins dealers or distributors around the world.

#### **Encompass Requirements:**

Must be purchased within 18 months\* or before expiration of base warranty, whichever occurs first from Date-In-Service (DIS).

Cummins recommended preventive maintenance procedures must be followed to qualify. See your Cummins Operation and Maintenance Manual for details.

Abuse, neglect, accidental damage or normal wear and tear are not covered.

All repairs under Encompass are to be performed by a Cummins distributor or full-service Cummins dealer.

Excessive oil consumption or blowby is not covered under this program.

A \$200 USD deductible charge (\$100 USD for B3.3/QSB3.3 engines, \$300 USD for 19L and larger) per service visit is the responsibility of Encompass customers.

\*There is a \$400 USD administrative fee if the extended coverage is registered from 12-18 months.

(Maximum coverage for all engine models used in forestry/logging applications is three years/unlimited hours.)
